#### Approval of agenda

Approval of minutes from March Telecom: Bill Tracy Moved, Unanimously approved. Regrets:

#### 2) Membership Committee (Don Jones)

a. Update on ACSESS progress on membership portal.

Fee based membership site is up and running. Please test the site to see if it is working well. Donn: Will this be discussed at the annual meeting. Don Jones will discuss this at the business meeting on Tuesday morning.

<u>Action:</u> Don Jones will compile a set of arguments for the reasoning for this step in NAPB and prepare a slide by the end of Wednesday of this week.

### 3) Advocacy Committee Update (Bill Tracy)

ASTA statement on breeding and crop development. Bill proposes for NAPB to endorse this statement. The Executive Committee would endorse it. Don B. and Donn C. support to endorse it. PBCC reviewed this as well and used it to get ideas for the re-write proposal. David Francis: The advocacy committee will discuss it and then present it to the Executive Committee for endorsement. We currently do not have a clear process. Ultimately we may want to develop a voting mechanism for the whole NAPB membership to vote for this kind of proposal. This needs to be discussed more long-term. David Francis: we need to make a faster decision. So for now we need to find a way to endorse with the Exec committee. Donn C.: we could have a comment period for a proposal and if no comment.

<u>Proposal:</u> The advocacy committee to develop and propose a formal process within NAPB to endorse external policy statements or approval of internally developed ones. This would include to evaluate when to have NAPB Exec. Comm. endorsements and when to have membership.

<u>Bill Tracy:</u> Survey on plant property protection has 60% participation. This will give some good information for discussion next summers meeting.

## 4) Interactions with CSSA (David Francis)

On May 26 we participated in a call with a CSSA board meeting. Charly Brummer was there. We had agreed to create a working group. We decided to meet Tuesday evening. It is unclear whether we should have a working group. Do we have and active liaison. We have ASTA D. C and D.B, CCPB T. Koch. Who else should we ask the working group? A mix of people that are involved with CSSA and those that are not. We need to ensure that we follow up on ideas. With ASTA we agreed to collaborate on the plant germplasm system but there was no follow up on that. David will send out a message to the EC to see who from CSSA will be there. Have the Exec. Comm. meet with the CSSA next week and find out what

the subjects would be. We could then form a project- focused working group with leadership. Our relationship with CSSA is 'like walking eggs". We might be seen as a takeover target by CSSA. We may help to broaden the discussion. The working group the we put together would need to include representation from non-seed crops and non-seed-propagated crops. Who should we have on our working group? It should include non-CSSA people. Who should we include from the non-seed crop side? Jim McFerson: to suggest a few people to be invited.
